

**MINUTES OF THE EIGHTY EIGHTH EMPANELMENT
AND DISCIPLINARY COMMITTEE MEETING HELD ON 25.06.2025**

In continuation of Eighty Seventh Empanelment and Disciplinary Committee meeting held on 28.05.2025, the Eighty Eighth EDC meeting was held on 25.06.2025 at TNHSP under the Chairmanship of Project Director. The following members participated in the meeting:

The hospitals are now selected/graded based on the documents uploaded and updated by them online. The score sheet of the hospitals will be uploaded in the website for transparency in an un-editable form.

Based on the documents submitted/inspection report hospitals who meet the criteria of the scheme empanelment have been selected. The hospitals need NABH entry level accreditation/equivalent GoI quality norms for empanelment. The hospital in process of doing accreditation/GoI quality norms are also eligible for empanelment. Exception can be provided for Standalone dialysis centre, Diagnostic center etc.

UIIC / TPA's are instructed to empanel the above list of hospitals, upload the packages, to appoint LO's for Government and Private Hospitals only and give training, create DMO, LO's login ID to access the scheme portal, supply of IEC material and other related activities. It is requested to sign the Memorandum of Understanding with the hospitals within ten days and submit a copy to TNHSP. From now onwards, TNHSP Medical officers should go for inspection of private hospitals along with the TPA team.


