Based on the documents submitted/inspection report hospitals who meet the criteria of the scheme empanelment have been selected. Otherwise they may not be able to continue in the scheme beyond that period. UIIC to communicate this to all the hospitals.

UIIC / TPA's are instructed to empanel the above list of hospitals, upload the packages, to appoint LO's and give training, create DMO, LO's login ID to access the scheme portal, supply of IEC material and other related activities. It is requested to sign the Memorandum of Understanding with the hospitals within ten days and submit a copy to TNHSP.
