ORDER:

The Project Director, Tamil Nadu Health Systems Project in his letter third read above has stated that the State Health Insurance Unit has been setup in the office of the Project Director, Tamil Nadu Health System Project and it is functioning for implementation of the Chief Minister's Comprehensive Health Insurance scheme. In the G.O. first read above, the following staff have been sanctioned to the State Health Insurance Unit to attend the works relating to the Insurance Scheme along with two vehicles for this Unit:

In the G.O. second read above, the following additional staff have been sanctioned to the State Health Insurance Unit to administer the Chief Minister's Comprehensive Health Insurance Scheme:

In both the above G.Os, no Accounts personnel has been sanctioned to the State Health Insurance Unit.

2. The Project Director, Tamil Nadu Health Systems Project has stated further that with the additional staff, the staff strength in State Health Insurance Unit has been increased and the work relating to accounts at this unit has also simultaneously increased.

3. The Project Director, has also stated that there is necessity for creating an Accounts Wing consisting of one Accounts Officer and one Accounts Assistant exclusively for State Health Insurance Unit to attend the works relates to disbursement of premium claims, obtaining Government funds, drawal of pay bill and other claims of the Health Insurance staff. The accounts work relating to Chief Minister's Comprehensive Health Insurance Scheme are now managed by the Finance Management Cell of Tamil Nadu Health Systems Project with much difficulty.

4. Considering the above facts, the Project Director, Tamil Nadu Health Systems Project has therefore requested the Government to sanction one post of additional posts to the State Health Insurance Unit.

5. The Government after careful consideration has decided to accept the proposal of the Tamil Nadu Health Systems Project and accordingly sanction for One post of Chief Accounts Officer in the cadre of under Secretary to Government Finance Department in time scale of pay of Rs. 15600-31900+ GP Rs.6600 and one post of Accounts Assistant in the scale of pay Rs.5200 – 20200 + GP 2400 to the State Health Insurance Unit for a period of one year from the date of filing up of posts. The Project Director, Tamil Nadu Health Systems Project, is permitted to fill up the post of Accounts Assistant by deputation from the Treasuries and Accounts Department. If it is not possible, he shall fill up the said post by out sourcing by following the rules in force for implementing the Chief Ministers Comprehensive Health Insurance Scheme.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:

7. Necessary additional funds will be provided in Revised Estimate / Final Modification Appropriation 2014-2015 to meet the expenditure sanctioned in para 5 above. Pending Provision of funds in Revised Estimate / Final Modified Appropriation 2014-2015. The Project Director, Tamil Nadu Health Systems Project is authorized to draw and incur the expenditure and he is requested to include the expenditure sanctioned above, while sending the Budget proposal for Revised Estimate / Final Modified Appropriation 2014-2015 to Government in Finance (Health II) Department without fail.
