ORDER:

Hon'ble Chief Minister under rule 110 on 25.08.2015 has announced that Rs.25.00 crore will be additionally provided for the Corpus Fund under Chief Minister's Comprehensive Health Insurance Scheme as the State share to meet the extra surgery cost of High end procedures under Chief Minister's Comprehensive Health Insurance Scheme as one time measure.

2. As per Government order read above, the existing sharing pattern of reimbursement occurring to Government Hospital under Chief Minister's Comprehensive Health Insurance Scheme is as follows:-

i. Incentive to medical team	-	15%
ii. Consumables	-	45%
iii. Hospital upgradation	-	20%
iv. Corpus Fund	-	20%

3. The Project Director, Tamil Nadu Health Systems Project has sent proposal to Government for seeking additional funds to the corpus fund to meet the extra surgery cost of High end procedures under Chief Minister's Comprehensive Health Insurance Scheme. He has further reported that under corpus fund, the contribution from the Government Hospital has been received to the tune of Rs.59.36 crore and Rs.53.42 crore has been spent on High end surgeries. As on date 1,747 cases have been approved for specialized surgeries and only 1066 cases have been paid surgery cost. The balance surgery cost to be paid is Rs.39.84 crore and representations are being received from hospitals to sanction the surgery cost earlier.

4. As the income from the receipt for corpus fund is insufficient. The Project Director, Tamil Nadu Health Systems Project has requested the Government to sanction a sum of Rs. 25.00 crore as one time grant as a special case to settle the balance surgery cost for high end specialized surgeries under Chief Minister's Comprehensive Health Insurance Scheme and to increase the sharing pattern to corpus fund from 15% to 20%.

5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health Systems Project and decided to revise the existing sharing pattern of reimbursement accruing to the Government Hospitals under Chief Minister's Comprehensive Health Insurance Scheme ordered in G.O.(Ms). No.331, Health and Family Welfare (EAPI/1) department, dated: 21.10.2014 as indicated below:-

6. The Government also sanction a sum of Rs.25.00 crore (Rupees twenty five crore only) to the Corpus Fund under Chief Minister's Comprehensive Health Insurance Scheme as one time measure.

7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:

2210. Medical and Public Health. 80 General 800. Other Expenditure Schemes in the Twelfth Five Year Plan.II State Plan. JL.Corpus Fund under Chief Minister's Comprehensive Health Insurance Scheme. 10 Contributions - 01.Contribution to Specific Fund.

8. Necessary funds will be provided in the FMA 2015-16. Pending provision of such funds in FMA 2015-16, the Project Director, Tamil Nadu Health Systems Project is authorized to draw and disburse the amount sanctioned in para 6 above. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the Supplementary Estimates 2015-16. The Project Director, Tamil Nadu Health Systems Project is also requested to include this expenditure while sending the budget proposals for FMA 2015-16 and draft explanatory notes for Supplementary Estimates 2015-16 to Government in Finance (Health-II) Department without fail.
