Order:

The Government in the G.O first read above have issued orders among other. to setup the State Health Insurance Unit in the Office of the Tamil Nadu Health System Project for administering the above scheme. In the said G.O the Project Director, Tamil nadu Health Systems Project was nominated as Nodal Officer to implement the above scheme. In the G.O Second read above orders were issued sanctioning certain posts and also funds to the State Health Insurance Unit in the office of the Project Director, Tamil nadu Health System Project. In the G.O third read above orders have been issued for the implementation of Chief Ministers' Comprehensive Health Insurance Scheme. The Scheme was inaugurated by Hon'ble Chief Minister on 11.1.2012. All the families with annual income of Rs.72,000/- and below are eligible to avail the benefits of the said scheme.

The Project Director, Tamil Nadu Health Systems Project has stated that following staff have been sanctioned to attend the works related to mis Insurance scheme alongwith two vehicles for this unit.

He has stated that though the day to day work is carried out with existing staff, much difficulty is being experienced for district level monitoring, statistics, publicity etc., and has proposed to expand the State Health Insurance Unit as comprehensive unit with additional staff to cover all the works related to insurance scheme and therefore is an urgent need for sanction of separate staff to attend the work.

3. The Project Director, Tamil nadu Health Systems Project has therefore, requested the Government to sanction Rs.4,04,00,000/- (Rupees Four crores and four lakhs only) for employment of following staff initially for a period of one year from the date of employment to attend the above work:
