ORDER:

In the Government Order first read above, orders were issued to collect Rs.5,000/- per Angio film from both paying and non-paying patients, if they wanted to take Angio films with them for their continued treatment.

2. The circumstances stated by the Project Director, Tamil Nadu Health System Project in the letter second read above that, in the earlier days of 1990s, the coronary angiograms done at government general hospital cardiac catheterisation laboratories were recorded in cine films. These films cannot be duplicated. When the concerned patient wanted to take the cine angiogram films outside, they were asked to pay a sum of Rs.5000/- to the government. After that, the newer cardiac catheterisation lab systems in the Government hospitals, angiogram videos are recorded in CD format. CDs unlike cine films can be replicated at considerably low cost. The amount of Rs.5,000/- collected from the Chief Minister's Comprehensive Health Insurance Scheme / non-Chief Minister's Comprehensive Health Insurance Scheme patient towards the CD is remitted by the patient to one of the hospital accounts. This money is paid by the hospital to the Government treasury. In this connection, an amount of Rs.1,47,24,000/- has been collected towards the fees for the Coronary angiogram CD and the same was remitted into the Government's Head of Account.

3. The Project Director, Tamil Nadu Health Systems Project has requested the Government to waive off collection of Rs.5,000/- for issue of Coronary Angiogram CD for patients, since it is out dated particularly it is being reimbursed

under Chief Minister's Comprehensive Health Insurance Scheme and to fix an amount of Rs.500/- for issuing the Coronary Angiogram CD for non-Chief Minister's Comprehensive Health Insurance Scheme patients.

4. After careful consideration of the request made by the Project Director, Tamil Nadu Health Systems Project at para 3 above, the Government have decided to accept the same and to waive off collection of Rs.5,000/- for issuing of Coronary Angiogram CD for Chief Minister's Comprehensive Health Insurance Scheme patients and an amount of Rs.500/- to be fixed for issuing the Coronary Angiogram CD for non-Chief Minister's Comprehensive Health Insurance Scheme patients.

5. This order issues with the concurrence of the Finance Department vide its U.O.No.36998/Finance (Health-II)/2022, Dated:16.08.2022.
